Local 831 has the following committees:

COPE works directly with area legislators on issues affecting workers. There are seven members. They also assist in voter registration and other manners pertaining to legislation.

By-laws Committee consists of three members. They review any requests of proposed changes to our by-laws and report their findings to membership.

Educational & Publicity -The committee consist of three members who are responsible for preparing the Informer, reporting to International on local issues of interest and other communications as directed by the President.

Membership Development & Organizing duties include encouraging and assisting those eligible for union membership to join as well as assisting other facilities to become union.

Skilled Trades Committees made of maintenance members of various trades. They meet to discuss job determinations, submit applications for journeyman cards and work with the maintenance Division Chairman on other issues pertaining to the skilled trades in our plant.

Civil Rights Committee meets to discuss any issues that surface pertaining to ones civil rights. They meet as necessary.

Women of Steel meets to discuss issues effecting our female workers.

Picnic committee is in charge of organizing and preparing an annual picnic for the members of local 831.

Relay for Life to be held in May

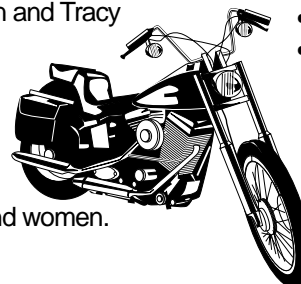

District 8 Scholarship 2004

"At the desk where I sit, I have learned one great truth. The answer for all our national problems - the answer for all the problems of the world - comes to a single word. That word is education," Lyndon B. Johnson, former President of the United States.

United Steelworkers of America, District 8, has always and continues to support education. Providing support to educate our member's young adults is achieved through our "Scholarship Program" for high school graduates of our brothers and sisters of participating locals in the Welfare and Education Fund. There will be four scholarships awarded in our district, one from each state of Kentucky, Virginia, West Virginia and Maryland. Total value of each scholarship is \$4000.00 (\$1000.00 per year). Any son, daughter or legal ward of active, retired or deceased USWA members in Local Unions participating in the District 8 Welfare and Education Program.

The applicant must be accepted for admission in an accredited college or university. The candidate however, should not wait for acceptance by a school before he or she files for the scholarship. Determining factors of receiving the award will include: High School Record, SAT/ACT Scores, Essay, Grade Point Average, Financial Need and Extra Curricular Activities.

Applicants must be postmarked on or before the fourth Friday in February - (February 27, 2004). Applications for the District 8 Scholarship can be picked up at the Union Hall.

• Local 831 will take letters of interest from union members on committee openings

• Two grievance appeals, both decisions of the grievance committee were upheld

• Motion to increase the price of The Informer ads from \$50.00 to \$75.00 for half page ad, quarter page ad from

\$25.00 to \$37.50 and business cards from \$15.00 to \$20.00

■ Benny Toller, Pension & Insurance Representative addressed the following items:

• Some providers are asking for the 10% co-pay up front because they are having problems getting individuals to pay their bills. They want to work out some type of payment arrangement if you cannot pay. The Doctors are calling Blue Cross/Blue Shield and getting the allowed amount first, then asking for the 10% co-pay in advance

• The drug co-pay went into effect on October 1, 2003

• If your spouse has insurance coverage with their employer and a claim is filed and paid, please keep the EOB (explanation of benefits). If Goodyear's BC/BS is secondary and the provider does not file for the secondary coverage, you will need the primary insurance EOB to file the claim

■ COPE committee member Byron Taylor gave a report on the winners of jackets who signed up for the PAC check-off and the winner of the Harley Davidson Motor Cycle

■ Dana Dixon and Paul Tucker won the 50/50 drawings

U.S. helps firms avoid overtime

WASHINGTON - The Labor Department is giving employers tips on how to avoid paying overtime to some of the 1.3 million low-income workers who would become eligible under new rules expected to be finalized early this year.

Avoiding overtime

The Labor Department is suggesting ways employers can avoid paying overtime to newly eligible workers. It offered this example of a "payroll adjustment":

A worker earning \$400 per week for 40 hours becomes eligible for overtime pay, which would average five hours a week. The employer can convert the worker to an hourly pay rate. But instead of paying \$10 an hour plus overtime, the employer can cut the worker's pay to \$8.42 an hour, or \$336.80, for a 40-hour week. The five hours of overtime pay at time-and-a-half - totaling \$63.15 - gets added to the reduced pay. The new pay with overtime equals \$399.95 per week, compared to the old salary of \$400 per week with no overtime.

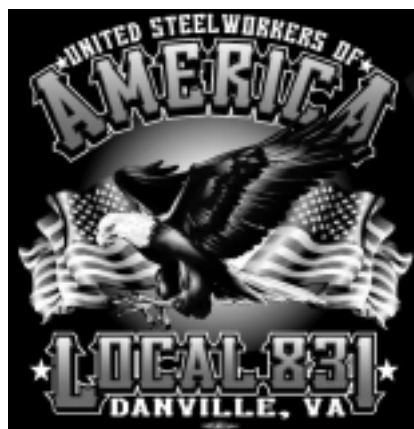

Questions Answers

If anyone has a question for *The Informer*, please submit it to Dana Dixon, Gloria Gravely, or Danny T. Ravina, your Division Chair.

Question-What is the procedure for shift preference when you bid on a new job?

Employees transferred or awaiting transfer **may** file a "Preferred Shift" card with the department to which they have or will be transferred. Such employees will not be eligible for shift preference rights until they have completed the learning time of the job, or 30 days from the job award date or transfer date, whichever is the lesser. Thereafter, their cards will be processed as outlined in Article X, Section 5.

The word **may** in the above language puts the burden of responsibility on the employee. The employee must ask for the shift preference card and must keep it up to date as they see fit. Failure to fill out a card or have a card filled out incorrectly could result in placement on whatever shift has the opening. Employees must fill out a new card every time you are awarded a new job. Your "Preferred Shift" card does not travel with you.
