When Americans No Longer Own America

The Dubai Ports World deal is waking Americans up to a painful reality: So-called "conservatives" and "flat world" globalists have bankrupted our nation for their own bag of silver, and in the process are selling off America.

Through a combination of the "Fast Track" authority pushed for by Reagan and GHW Bush, sweetheart trade deals involving "most favored nation status" for dictatorships like China, and Clinton pushing us into NAFTA and the WTO (via GATT), we've abandoned the principles of tariff-based trade that built American industry and kept us strong for over 200 years.

The old concept was that if there was a dollar's worth of labor in a pair of shoes made in the USA, and somebody wanted to import shoes from China where there may only be ten cents worth of labor in those shoes, we'd level the playing field for labor by putting a 90-cent import tariff on each pair of shoes. Companies could choose to make their products here or overseas, but the ultimate cost of labor would be the same.

Then came the flat-worlders, led by misguided true believers and promoted by multinational corporations. Do away with

those tariffs, they said, because they "restrain trade." Let everything in, and tax nothing. The result has been an explosion of cheap goods coming into our nation, and the loss of millions of good manufacturing jobs and thousands of manufacturing companies. Entire industry sectors have been wiped out.

These policies have kneecapped the American middle class. Our nation's largest employer has gone from being the unionized General Motors to the poverty-wages Wal-Mart. Americans have gone from having a net savings rate around 10 percent in the 1970s to a minus .5 percent in 2005 - meaning that they're going into debt or selling off their assets just to maintain their lifestyle.

At the same time, federal policy has been to do the same thing at a national level.

Union Leader Rejected By House

The House of Delegates rejected Virginia Governor Timothy Kaine's appointment of former union leader Daniel LeBlanc, on March 7, 2006.

The House, which is controlled by the Republicans, stripped LeBlanc's name from a list of appointees who must be confirmed by both legislative chambers. The Senate, which is also controlled by Republicans, had unanimously approved the appointment. All Republicans in the House voted against LeBlanc while all Democrats voted for the appointment.

"I view it as not just as an affront to me

and to the Senate and to Danny (LeBlanc) but I view it as basically spitting in the face of regular working people, who had Danny (LeBlanc) as their champion," said Kaine.

LeBlanc, who formally served as state president of the AFL-CIO, has held opposition to the state's right to work law. He also has had criticism from some of Virginia's biggest employers when standing up for working people. Republicans said they couldn't abide LeBlanc's appointment because he had said he was proud to have been arrested with United Mine Workers members during a

PENSION & INSURANCE

■ DANVILLE REGIONAL MEDICAL CENTER

There has been a lot of concern regarding the hospital charging deductibles, co-pays and co-insurance amounts upfront when there is a scheduled procedure to be done. Life point implemented this change after the sale of the hospital. A meeting had been set up with Tod Lambert, CEO of DRMC on Friday March 10, 2006 to discuss the above issues, but the Union has been informed that Mr. Lambert had resigned so the meeting has been canceled. If there are any further discussions on these issues we will keep you informed.

■ EMPLOYEE STOCK OPTION PLAN

Effective December 5, 2000, stock options were granted for Bargaining Unit Employees covered under the Master Agreement. There are 429 employees who did not complete a stock option grant agreement at the Danville plant. A General Notice and a list of those employees will be placed on the boards inside of the plant. We are encouraging everyone to check the list to see if your name is on it. If so, then you can go by the HR department and see B.J. Jenson or Marion Purnell to pick up your Stock Option Agreement. The completed forms need to be returned to the HR department.

■ ADD/ADHD CLAIMS

There are quite a few concerns about claims denying for Attention Deficit Disorder. ADD or ADHD claims are specifically listed as exclusions under our plan policy. The language reads, "For or related to developmental delays, autistic disease, learning disabilities, hyperkinetic syndrome or mental retardation". Therefore the plan only covers services for ADHD up to the time that the diagnosis is confirmed. There were claims that paid in the past but it was done in error. Blue Cross Blue Shield detected the error and has stopped paying for any services related to ADHD. This exclusion can be found on page 56 of your Blue Cross Blue Shield Health Benefit Booklet.

When Americans No Longer Own America

Because our so-called "free trade" policies have left us with an over \$700 billion annual trade deficit, other countries are sitting on huge piles of the dollars we gave them to buy their stuff (via Wal-Mart and other "low cost" retailers). But we no longer manufacture anything they want to buy with those dollars.

So instead of buying our manufactured goods, they are doing what we used to do with Third World nations - they are buying us, the USA, chunk by chunk. In particular, they want to buy things in America that will continue to produce profits, and then to take those profits overseas where they're invested to make other nations strong. The "things" they're buying are, by and large, corporations, utilities, and natural resources.

Back in the pre-Reagan days, American companies made profits that were distributed among Americans. They used their profits to build more factories, or diversify into other businesses. The profits stayed in America.

Today, foreigners awash with our consumer dollars are on a two-decades-long buying spree. The UK's BP bought Amoco for \$48 billion - now Amoco's profits go to England. Deutsche Telekom bought VoiceStream Wireless, so their profits go to Germany, which is where most of the profits from Random House, Allied Signal, Chrysler, Doubleday, Cyprus Amax's US Coal Mining Operations, GTE/Sylvania, and Westinghouse's Power Generation profits go as well. Ralston Purina's profits go to Switzerland, along with Gerber's; TransAmerica's profits go to The Netherlands, while John Hancock Insurance's profits go to Canada. Even American Bankers Insurance Group is owned now by Fortis AG in Belgium.

Foreign companies are buying up our water systems, our power generating systems, our mines, and our few remaining factories. All because "flat world" so-called "free trade" policies have turned us from a nation of wealthy producers into

a nation of indebted consumers, leaving the world awash in dollars that are most easily used to buy off big chunks of America. As www.economyincrisis.com notes, US Government statistics indicate the huge percentages of foreign ownership of American industry.

Attorney's Advice -- NO CHARGE

Read this and make a copy for your files in case you need to refer to it someday. Maybe we should all take some of his advice! A corporate attorney sent the following out to the employees in his company.

1. Do not sign the back of your credit cards. Instead, put "PHOTO ID REQUIRED".
2. When you are writing checks to pay on your credit card accounts, DO NOT put the complete account number on the "For" line. Instead, just put the last four numbers. The credit card company knows the rest of the number, and anyone who might be handling your check as it passes through! All the check processing channels won't have access to it.
3. Put your work phone # on your checks instead of your home phone. If you have a PO Box use that instead of your home address. If you do not have a PO Box, use your work address. Never have your SS# printed on your checks. (DUH!) You can add it if it is necessary. But if you have it printed, anyone can get it.
4. Place the contents of your wallet on a photocopy machine. Do both sides of each license, credit card, etc. You will know what you had in your wallet and all of the account numbers and phone numbers to call and cancel. Keep the photocopy in a safe place. I also carry a photocopy of my passport when I travel either here or abroad.

Is the Union Hall rented out for parties, church events, reunions, etc?

The answer is yes. If a person wants to rent the union hall, they must first come to the hall and have \$200.00 to put down for the security deposit. After the \$200.00 is paid, the date is locked in for the individual wanting to rent the hall. One week prior to the event, \$400.00 is due. This is the actual price to rent the hall. Total at this point is \$600.00. Before the event, a union official will go over the rules and regulations that are required in renting. Four hours is the maximum hours one can use, unless more hours are needed. The price for extra hours is \$100.00 for each hour after four hours. No matter how many hours are needed for the event, it cannot exceed past 1:00 am. Everyone should be off the premises soon after 1:00 am.

There is always a union official that oversees any event at the hall. If the individual who has rented the hall has complied with the rules and regulations and there is no damage, \$200.00 will be reimbursed to the individual renting the hall.

strike in the late 1980s. Mr. LeBlanc had his arrest warrant framed and it hung on his wall until Kaine appointed him secretary of the commonwealth. Del. Jennifer L. McClellan, D-Richmond, said he was right to be proud of it.

Local 831 Union President Danny Barber said, "It's obvious that those who voted against LeBlanc being appointed was looking out for the interest of big business and the wealthy and not the interest of everyday working people. In my opinion, LeBlanc was chastised for standing up for the working men and women of this country."

Delegate Jeion Ward, a Democrat and president of the Hampton Federation of Teachers, said the House was sending a message that union members were unfit for government service.

Legislators from the area that voted in the House against LeBlanc's appointment were: Del. Danny Marshall, Del. Robert Hurt, Del. Allen Dudley and Del. Clarke Hogan. Supporting the nomination was: Del. Ward Armstrong, Sen. Roscoe Reynolds and Sen. Charles Hawkins.

USW: Conti's Tire Production Suspension - NOT A SURPRISE

PITTSBURGH (March 10) -- Continental Tire North America Inc. announcement to suspend tire production at its Charlotte, N.C. plant this September is not a surprise, the United Steelworkers union commented today.

"The news today is totally consistent with CTNA's inability to understand and operate in this environment," said USW executive vice president Ron Hoover, who heads the union's Rubber/Plastics Industry Conference. "We view it as another step in CTNA's pre-determined plan to abandon the North America market."

The USW and CTNA have been engaged in talks to see if maintaining the Charlotte productivity is possible. The company has demanded \$32 million in yearly concessions, but the union claims Conti hasn't demonstrated the need for these savings. The USW has offered proposals to reduce costs and improve productivity and efficiencies, but Conti has "flat-out refused to look at ways to enhance productivity," the union said.

The indefinite suspension plan is part of the firm's restructuring program aimed at reducing manufacturing costs and improving the performance of Conti's North American passenger tire business, according to Alan Hippe, president and CEO on the Continental Tire North America.

Hoover, however, said the company has refused to "engage us in a productive process that would yield a business plan to preserve the production of tires in Charlotte and the long-term viability of Continental in North America."

If the suspension is implemented, about 478 hourly and salaried employees at the facility will be laid off, Conti said. The firm emphasized it did not plan to close the plant and will continue rubber mixing, calendaring, puncture sealant and warehousing operations to support its other manufacturing facilities.



Election procedures explained

So You Are New To The Voting Process

There are many new faces in USW Local 831, not only Goodyear, but also Alisco, URW Credit Union and the Goodyear Gemini Store. For those people, this story is a step-by-step guideline of how voting actually works and what the member must do.

The first step is now complete with the nominations being held on March 9th. The selected voting committee members will check the membership meeting books to ensure that all candidates have the proper number of meetings to be eligible to run (8 meetings in 2 years). Once that is complete and any that are not eligible are removed from the roster, the committee will draw candidates' names out of a hat, by office, for their official placement on the voting machine and/or paper ballot.

Election days have been set for April 4th & 5th and the voting will take place at the Goodyear plant employee entrance. A tent will be set up

with tables. Above the tables will be posters stating which departments or group of departments will be in that line. You must get in the proper line to be able to vote. The reason for the lines by department is to ensure that each member is allowed to vote on officers but are also allowed to vote in their respective Division Chairman races. As you reach the table, you must state your name and clock card number so that the election committee can strike your name from the roster to show that you have voted. Only one vote is allowed per member. At this time you will be given a paper ballot and a card to get you into one of the voting booths. Each Division Chairman's paper ballot will be different colors to keep from mixing up the voting. Paper ballots will be placed in the ballot box and the member will then move on to the voting machines to cast their votes for other officers. If you have never used a voting ma-

chine, there will be a sample machine setup and someone to show you how to use it.

For candidates—none are allowed within a certain distance of the voting polls. Signs are allowed at a distance but none within the voting area. Results of the votes will be taken immediately following the close of the election on April 5th. No results will be officially released prior to the completion of the counting of the paper ballots (which may be hours).

Offices where only one person is needed must be won by a majority vote (more than 50%). If more than two people are running and one does not get a clear victory, a run-off election of the two top vote getters will be held on April 11th & 12th. The same setup will be in place for the run-offs. Voting times for both elections, all four days will be 5:30 a.m. until 8:30 p.m.
